BE IT ORDAINED by the President and the Board of Trustees of the Village of Kingston, DeKalb County, Illinois, as follows:

SECTION 1. That Chapter 74, Section 68, Stop Signs, of the Kingston Municipal Code shall be amended to include the follow stop sign location:

North and South on East Street at Second Street

SECTION 2. VALIDITY

- (a) All Ordinances or parts of Ordinances in conflict herewith are herby repealed to the extent that they conflict with this Ordinance, or any part of this Ordinance.
- (b) If any provision contained in this Ordinance is found to be invalid, such provision shall be deemed to be severable and shall not affect the validity of any of the remaining provision of the ordinance.
